ONLINE applications are invited from the eligible candidates of Kashmir and Ladakh for admission to the B.Ed Programme session 2021-23 at School of Education & Behavioural Sciences University of Kashmir, Srinagar and South Campus, Dept. of Education, University of Kashmir, Anantnag. The application forms can be downloaded from the Kashmir University official website www.kashmiruniversity.net or www.kashmiruniversity.ac.in from 25th November, 2021 To 9th December 2021 and the auto-generated copies (hard copies) of the application form/s and fee receipt should reach Office of the College Development Council by or before 14th December 2021 along with the following documents:

- 1) 1st, 2nd and 3rd year Marks Certificates of graduation;
- 2) P.G. marks Certificate/s, if any;
- 3) Valid Category certificate, if any, as issued by the respective Competent Authority.

The requisite application form fee of Rs.750/-(including IT fee) should be deposited by using the downloaded Pay-in-Slip favouring to Dean, College Development Council's J & K Bank Finacle Account No. 0007010100002714.

Eligibility:

- i) Graduation in any discipline from the University of Kashmir or from any other University recognized as equivalent thereto by the University of Kashmir with 50% marks (General category) and 45% marks (Reserved category) as envisaged in the NCTE quidelines
- ii) Graduation under 10+2+2 scheme with 2 years teaching experience in the Govt. or Govt. recognized private school with 50% marks (General category) and 45% marks (Reserved category) in case of teacher candidates.
- iii) Candidates having obtained P.G Degree with 50% marks (General category) and 45% (Reserved category) marks are also eligible to apply for the course.
